1. Introduction:

WBECSC Ltd., an undertaking of, Govt. of West Bengal invites Re e-Tender for selection of manufacturer / supplier of Weighing Machines for weighing upto 500 kg (5 quintal) of paddy/food grain procured. Re e-Tenders in two separate parts i.e. Technical Re e-Tender and Financial Re e-Tender are invited from Eligible Re e-Tenders. The Re e-Tenders will have to fulfil the following minimum criteria on their own or as a main vender in case of consortium.

SPECIFICATIONS OF WEIGHING MACHINES:

- 1) Model approved by Govt. of India (copy of Model approval certificate must be produced)
- 2) Maximum Capacity = 500 kg
- 3) Class = III
- 4) $e = d = 50$ g, Minimum capacity = 1 kg
- 5) Verification certificate of the Weighing Instrument
- 6) Warranty 1 yr.
- 7) Directly plug in & Battery backup for 2 days
- 8) White LED display
- 9) Over load protection
- 10) Pan size – 24" × 24"
- 11) Weighing scale should get verified and stamped by the Inspector of Legal Metrology
(Govt. Statutory Officer)
- 12) Battery standby for 6 months.

ELIGIBILITY CRITERIA & SPECIFICATION:

Eligibility Criteria:

1. The supplier must have an experience of supplying Weighing Machine for at least three years in bulk quantity to any Govt. / Govt. undertaking / Govt. aided / Private company.
2. The Supplier must have an annual turnover of not less than Rs.50,00,000/- (Rupees fifty lakhs only). The bidder has to upload the copy of Audited Balance sheet with an annual turnover of not less than Rs.50,00,000/- (Rupees fifty lakhs only) per year, duly audited by the competent authority, for the last 03 (three) financial years i.e. 2017-18, 2018-19 & 2019-20.
3. The bidder must submit valid Certificate of Registration / Incorporation / Partnership Deed / Memorandum of Association.
4. The Bidder should upload PAN Card as issued by Income Tax Deptt.
5. The bidder has to upload the valid GST Registration Certificate.
6. The bidder has to submit the Copy of Income Tax statement for 2017-18, 2018-19, 2019-20.
7. Dealership license of the Supplier.
8. Perspective bidders shall have to deposit an Earnest Money of Rs.15,000/- (Rupees fifteen thousand only) to be submitted through Online Tender Portal.
