Interested bidders having due eligibility and offering the highest rate above the base price will be selected as the highest bidder (H1) and the work order will be issued to that bidder. The quoted rate will be valid for 1 (one) year.
- 4) **Interest:** An EMD at the rate 2% of the base price is to be deposited in the form of demand draft along with the Bid Documents.
